Street (Heller Road) across from N.W. 8th Avenue. Avenue. Near Oak Harbor, Washington. The property currently is vacant A project description, prepared by the applicant, is included in this application.

The project is located along the easterly margin of 150 N.W. Street (Heller Road) across from N.W. 8th Avenue., Oak Harbor, Washington. The proposal is located in Section 34, Township 33 North, Range 1 East, Willamette Meridian. The applicant has submitted legal description, site plan and a vicinity map.

The slope of the site generally trends towards the north and east , predominantly ranging from 0% to 5%.

Per geotech report two earthquakes faults falls within two mile of this site but low potential for soil liquefaction.

- e. Describe the purpose, type and approximate quantities of any filling or grading proposed. Indicate source of fill.

An estimated 2,500 yards cut and 2,500 yards fill of material is needed to bring the site grade to the desired elevation. The majority of the on-site material will remain on-site, while additional material (as needed) will be imported from an approved source. These volumes may adjust when actual grading plans are completed.

- f. Could erosion occur as a result of clearing, construction, or use? If so, generally describe.

During construction, soil erosion may occur but will be minimal due to the gentle site grade within the building envelopes and soil type. On-site construction will utilize Best Management Practices (BMP). Following construction, the erosion potential would decrease drainage is controlled and cleared areas are re-vegetated.

The applicant will comply with the DOE 2005 storm water manual for erosion control on site.

Approximately 45.0% of the property will be covered with impervious surfaces from the constructed driveways and buildings following the full development of the property.

- h. Proposed measures to reduce or control erosion, or other impacts to the earth, if any:

Temporary measures to control soil erosion include silt fencing, straw bales, mulching, hydroseeding, and/or other Best Management Practices (BMP) that will be utilized to minimize erosion and other impacts to the earth. Additional storm water and erosion control BMP's will be implemented as necessary to meet city and DOE standards. See geotech report for the project for any additional seismic design standards

During construction, activities there would be increased exhaust and dust particle emissions to the ambient air. The roofing of homes could also cause objectionable odors. The slight increase in automobiles associated with the development would contribute emissions, typical to automobiles, to the ambient air. Finished homes will include vents for dryers and furnaces constructed to code standards and state air quality standards.

After construction the water will be treated and detained storm water in a rain garden

Wastewater will be discharged into city of Oak Harbor's sewer district's Sewer system. It is not anticipated for any waste materials to discharge to the surface waters. Storm water BMP's will be implemented per DOE requirements.

This application is proposing storm water infiltration and an infiltration galley per DOE standards..

Through the construction of residences and driveways, the existing runoff pattern would be locally modified. Runoff from the proposal would be generated by building roofs, driving, and other impervious surfaces. This application is proposing to treat and detain storm water in a rain garden and infiltration gallery
