EVENT RULES & GUIDELINES

COME JOIN THE FUN AND HELP GIVE CRIME A BOOT OUT OF TOWN!

- Vendors may set up anytime from 1:00 pm-2:00 pm. All vehicles must be stationary once the event opens to the public at 3:00 pm.
- Locations/Space Numbers will be assigned upon arrival.
- Festivities start promptly at 3:00 pm. Early closing and breaking down is not permissible.
- Booths, products and displays will be viewed by all ages.
- To help defray the cost of the event, the following fee schedule applies: \$10 for booths-***no sales are allowed except by food vendors***. To make this a family event with community interaction: **all booths must have a child/ family activity or demonstration associated with their booth**. Electricity is available on a limited basis, please specify on your registration form if this is needed.
- **Food Vendors** pay a \$25 fee.
- Booth space will be assigned in approximately 12 x 10 feet intervals. **If you need more space for your site, please specify how much area your display requires.** All booths, display boards, tables, chairs and other equipment, must be supplied by the participating organizations. Since booths will be outside, a tent or cover is highly recommended.
- Booths must be attended at all times.
- Each food vendor will be responsible for conducting their own sales and collecting their own sales tax.
- You are responsible for keeping your area clean during and after the festival, making sure all trash is removed at the end of the event.
- The City of Oak Harbor, National Night Out Committee, United Way of Island County and sponsors/presenters will not be responsible for any damage to booths, equipment, food, injury, property damage or loss sustained as a result of participating in this event.
- We recommend for your protection, that you carry insurance coverage during the event. This is for protection against bodily injury and personal damage to your merchandise. This may be obtained by contacting your personal insurance agency. Often, special policies can be attached to a homeowner's policy to cover these activities.

ADDITIONAL FOOD VENDOR REQUIREMENT

- Each food vendor is responsible for their own permits and licensing. Please make sure you have secured your Island County Health permit (360) 679-7350. Please be sure to bring a copy of your health card.
