7.20.030	<u>Notification of owner – Redemption fee.</u> <ul style="list-style-type: none"> <li>• Owner reclaiming an impounded cat</li>   <li>• Owner reclaiming an impounded dog: <ul style="list-style-type: none"> <li>- For the first offense</li> <li>- For the second offense and subsequent offenses</li> </ul> </li> <li>• Additional impound fee for dogs after the first 24 hours</li> <li>• If the impounded animal is unlicensed and its owner has been a resident for over 60 days, the owner shall pay a fine</li> </ul>	\$15.00 plus \$5.00 board fee for each calendar day cat impounded  \$15.00 \$25.00  \$5.00 for each calendar day \$25.00 over and above the impoundment fees
