Yard Waste 95 Gallon Rollcart Program Subscription
Garbage Customers Only

What can I place in my yard waste rollcart?

Acceptable yard waste material must consist of grass, leaves, pine needles, pinecones, thatch, vines, weeds, and branches or other such fresh yard waste type material, not putrefied. Woody material must be no more than 3 inches in diameter and not extend outside the approved collection container. **Total gross cart weight may not exceed one hundred fifty pounds and prepaid bags shall not weigh more than fifty pounds.**

Non-acceptable yard material consists of sod (beyond small amounts), rocks, dirt, gravel, concrete, glass, metal, plastic bags, household solid waste and recyclables, animal feces, paint residue, holiday decorations, paper flocking, dimensional lumber, stumps or roots. A load will not be serviced if it emanates a strong odor detectable by an ordinary person at a distance of thirty (30) feet.

What happens if I place non-acceptable yard material in my rollcart?

Unacceptable loads submitted as clean yardwaste will be left by collection crews and must be handled as a category solid waste. The rate shall be as for a 95-gallon automated style container as set in OHMC 15.04.150. Rollcart service will be terminated by the Solid Waste Dept if contamination continues.

When is my yard waste collected?

The service will consist of two seasons. The Peak season will be from March 1st to November 30th. During Peak season, yard waste will be serviced weekly on garbage collection day. The Off season will be from December 1st to the end of February. During the Off season, yard waste will be serviced once a month on the garbage collection day in the first week of the month.

Where is my yard waste collected?

Yard waste containers shall be placed in a solid waste utility designated location no later than 7:00a.m. on the scheduled collection day. Such location shall be easily accessible to the solid waste vehicle. All containers must face in the proper direction with the lids completely closed. All containers must be unobstructed with a minimum of two feet of clearance around the container for the automated truck to pick it up. In areas where the solid waste utility designated location for an automated collection container is at street-side, it shall be the duty of each customer to remove the container from street-side on the same day as collection.

When is my yard waste service billed?

The service is billed and payable monthly, as follows:

Can I use non City Bags or Rollcarts for yard waste collection?

Service is provided only in designated City of Oak Harbor 95-gallon rollcarts and prepaid yard waste bags that are available for purchase at Haggens, Saar's Marketplace, and City Hall Utility Office. The customer is responsible for the cost of cart replacement in case of loss or damage.

There is no container delivery charge for the first delivery to a given customer. There will be a trip fee of 25.70 for subsequent roll cart deliveries.
